

## PUBLIC DISCLOSURE OF DISPOSITION OF ANTI-DOPING MATTER UNDER RULE 14.3.2 - FERNANDA MARTINS (BRA)

1. On 24 April 2021, Fernanda Martins<sup>1</sup> (“the **Athlete**”) provided a Sample Out-of-Competition during Doping Control conducted by the Athletics Integrity Unit (“**AIU**”) on behalf of World Athletics, which resulted in an Adverse Analytical Finding for Enobosarm<sup>2</sup> (“the **AAF**”) which is a Non-Specified substance, prohibited at all times.
2. On 21 May 2021, the AIU notified the Athlete of the AAF and imposed a Provisional Suspension.
3. On 7 July 2021 the AIU charged the Athlete with Anti-Doping Rule Violations (“**ADRVs**”) pursuant to Rule 2.1 and Rule 2.2 of the World Athletics Anti-Doping Rules (“**ADR**”).
4. The Disciplinary Tribunal rendered an operative award in the Athlete’s case on 23 July 2021 (with the reasoned award provided on 4 August 2021) which found that the Athlete had committed an ADRV and imposed a period of Ineligibility of two (2) months commencing on 23 July 2021 with credit for the period of Provisional Suspension served since 21 May 2021.
5. The AIU appealed the Disciplinary Tribunal decision to the Court of Arbitration for Sport (“**CAS**”) on 2 September 2021.
6. The AIU, the Athlete and the World Anti-Doping Agency subsequently entered into a Case Resolution Agreement in accordance with Rule 10.8.2 ADR pursuant to which:
  - 6.1. the Athlete acknowledges to have committed an ADRV under Rule 2.1 of the ADR;
  - 6.2. the Athlete agrees to be sanctioned for the ADRV with a period of Ineligibility of nine (9) months and sixteen (16) days pursuant to Rule 10.6.1(b) of the ADR;
  - 6.3. taking into consideration the time served because of the Athlete’s Provisional Suspension, the period of Ineligibility commences on 1 August 2021 and shall be in effect until, and including, 15 March 2022;
  - 6.4. in accordance with Rule 10.10 of the ADR, the Athlete’s competitive results from 24 April 2021 until the date of the Disciplinary Tribunal Decision viz. 23 July 2021 are Disqualified with all resulting consequences, including forfeiture of any medals, points and prize money/prizes; and
  - 6.5. any further competitive results that the Athlete obtained from 1 August 2021 to date are automatically disqualified, with all resulting consequences, including forfeiture of any medals, points and prizes.
7. The Case Resolution Agreement resolved the dispute between the parties before CAS.

8. The disposition of the Athlete's case is now final under the ADR and is published in accordance with Rule 14.3.2 ADR.
